

PROSPECTUS

Commerce & Humanities Plus Two Course



COURSE OF STUDY

The senior school curriculum prescribed by the Central Board of Secondary Education, Delhi is offered here as the course of study as the school is affiliated to the CBSE upto the Senior Secondary level.

On successfully completing the regular course of study of class XI and passing the final examination of Std. XI as per norms, students will be promoted to class XII. On successfully completing the regular course of class XI as per school norms, the students will be forwarded for the All India Senior School Certificate Examination conducted by the CBSE, Delhi. Regular course of study means at least 80% attendance in the classes held. Students who will attend classes regularly should only apply for admission. The school does not sponsor non attending/flying candidates on any account.

ADMISSION TO CLASS XI

ELIGIBILITY

Apart from the minimum qualification prescribed by the CBSE, the school will consider the following for admission to class XI.

- (i) Excellent academic performance in the All India Secondary School Examination, the Entrance Test, the Pre-Board Examination and the class IX Examination,
- (ii) Regularity in Attendance in class IX and X. Those who have less than 75% attendance in class X shall not be considered,
- (iii) Character and conduct of the candidates must be to the full satisfaction of the school management represented by the Director and the Principal.
- (iv) The management reserves the right to admission and its decision shall be final and binding.

DIRECT ADMISSION

Students who secure marks/grades according to the schedule published may be admitted directly but must appear and pass the interview/Aptitude Test.

The office may be contacted for further details.

ENTRANCE TEST

- (i) Candidates seeking admission to the Plus Two Course who do not have the prescribed minimum grades/marks have to appear for the +2 Entrance Test.
- (ii) The test shall comprise of only one paper consisting of questions from English, Social-Science, (Mathematics for Commerce Stream) and General Studies.
- (iii) It shall be of two hours duration.
- (iv) Apart from testing the subject knowledge of the candidates as per curriculum of Std. IX & X, Questions will be asked so as to assess the Scholastic aptitude of the candidates.

INTERVIEW

- (i) Provisionally selected candidates will be called for an interview.
- (ii) The parents of the candidates provisionally selected, have to be present at the time of interview with the necessary documents in original.

CHOICE OF ACADEMIC STREAM

No candidate shall be permitted to change his/her subject to study after passing class XI, in case of too many candidates applying for one particular stream, some of them may be asked to study another stream. The Principal's decision will be final on this matter.

FEE

- 1. The school tuition fee for one year for Std. XI will be Rs. 45,600/- for Commerce & Humanities students. Tuition fee will be charged on Quarterly basis in advance. For Admission and other charges the school office counter may be contacted. Computer fee for IP will be charged separately @250/-per month.
- 2. If the student leaves the school during the Plus two course no fees are refundable.

UNIFORM

CONDUCT AND DISCIPLINE

The Plus two Course being a part of School Education, in matter of conduct, discipline attendance, uniform, activities and school timing, plus two students are expected to follow the norms and regulations applicable to other students of this school.

Continued idleness, use of bad language or behaviour, chewing of pan masala or consumption of any form of intoxicants, drugs, damaging school/public property etc. and particularly any offences against honesty morality will expose the offender to immediate dismissal/rustication.

GENERAL INFORMATION

- 1. The School provides transport facilities to the students at the prescribed rates. Though all precautions are taken the management will not be responsible for any untoward incident/accident due to the negligence of the driver or staff.
- 2. Students are not permitted to bring any vehicle other than cycle into the school campus. Use of cell phones are strictly prohibited.
- 3. Some relaxation in cut off marks will be given to sports person who have played at state / national level.
- 4. Students must attend class regularly and it is mandatory to complete 80% of regular attendance in class failing which the student will not be promoted or allowed to appear at the Board Examination as per norms.
- 5. Married Students will not be admitted in the school neither will they be allowed to attend class in case they marry during the session. The School is meant for unmarried scholars only.
- 6. Students are required to have proper hair-cut and no beard.
