OF

1. Name of the Society : "ST. DOMINIC SAVIO'S HIGH SCHOOL"
2. Registered Office : The Registered Office of the Society shall be situated at "North Sri Krishnapuri, Patna 800013. The Registered Office may be changed at any time by the Society and it will be intimated to I.G. Registration, Bihar, within 15 days before such change.
3. Area of operation : The area of operation shall be all over India.
4. Aims & Objective : The aims and objectives of the Society are:
 - a) To establish and administer education Institutions i.e., Kindergarten, Primary, Middle and High Schools for the present and a college (Art, Science and Commerce) in future through the medium of English Language the mother tongue of the Anglo-Indian Community. Further the object is to give students a complete education of body, mind and spirit irrespective of religion, race, caste, and language and to help them develop their full personality.
 - b) To start cultural, handicraft and adult educational schools when possible.
 - c) To undertake charitable work when and where required and also give scholarships and fee concession to students from the economically weaker sections including the Anglo-Indian community.
 - d) To provide vocational training, small scale industrial training and cottage industries, computer, typing, shorthand & technical training to poor youths, women and children for their self employment & also arrange self-financed housing schemes.
 - e) To provide relief measures among the affected people at the time of flood, fire, famine, clothes and food freeing the affected area and also provide rehabilitation centres.
5. The management of the affairs of the school is entrusted in accordance with the Rules and Regulations of the society to a managing committee to be appointed by the Governing Body and shall comprise of its members and others nominated by the Governing Body.


